ORDER

As per letter read as 1st paper above, Executive Director, Kerala Social Security Mission has informed that as per the disability census 2015 there are 1,66,740 BPL Persons with the disabilities such as Blindness, Low Vision, Leprosy Cured, Hearing Impairment, Locomotor Disability, Mental Retardation and Mental Illness in the age group of 0-65. It is proposed to enrol 1,00,000 such persons under the Swavlamban Health Insurance Scheme in the current financial year. The total amount required for providing this social security support scheme comes to Rs.3,57,00,000/-.

2. In the budget estimate for 2016-17 there is an allocation of Rs.17.50 crores(Rupees seventeen crores and fifty lakhs only) to SID under the Head of account 2235-02-101-69(03). The Executive Director, Kerala Social Security Mission has requested to accord sanction to release an amount of Rs. 3,57,00,000/-from the current year's budget for providing the social security support scheme of Swavlamban Health Insurance Scheme so as to enrol 1,00,000 Persons with the disabilities such as Blindness, Low Vision, Leprosy Cured, Hearing Impairment, Locomotor Disability, Mental Retardation and Mental Illness who are in the age group of 0-65 under the head of account 2235-02-101-69(03)(P) and transfer credit the same to the special TSB A/c No. 103 in the name of State Initiative on Disabilities at District Treasury, Thiruvananthapuram.

3. As per Minutes read above, the Working Group held on 22.12.2016 has approved the proposal.

4. In the circumstances, Government are pleased to accord Administrative Sanction for an amount of Rs. 3,57,00,000/- (Rupees three crores fifty seven lakhs only) for providing the social security support scheme of Swavlamban Health Insurance Scheme to enrol 1,00,000 Persons with the disabilities such as Blindness, Low Vision, Leprosy Cured, Hearing Impairment, Locomotor Disability, Mental Retardation and Mental Illness who are in the age group of 0-65 from the current year's budget under the head of account 2235-02-101-69(03)(P) and transfer credit the same to the special TSB A/c No. 103 in the name of State Initiative on Disabilities at District Treasury, Thiruvananthapuram.
