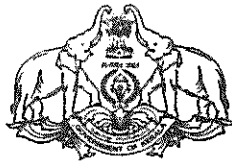

(This does not form part of the notification, but is intended to indicate its general purport.)

Section 84 of the Rights of Persons with Disabilities Act, 2016 (Central Act 49 of 2016) provides that the State Government shall, with the concurrence of the Chief Justice of the High Court, by notification, specify for each District, a Court of Session to be a Special Court to try the offences under this Act. Therefore Government, in consultation with the Chief Justice of the High Court of Kerala, have decided to designate one Additional District and Sessions Courts in each District as Special Courts under the said Act.

The notification is intended to achieve the above object.

S. R. O. No. 979/2019

In exercise of the powers conferred under sub-section (1) of section 85 of the Rights of Persons with Disabilities Act, 2016 (Central Act 49 of 2016), the Government of Kerala hereby specify the Additional Government Pleaders and Additional Public Prosecutors who are in charge of the courts which are notified as Special Courts as per section 84 of the said Act vide S.R.O. No. 878/2018 and published in the Kerala Gazette Extraordinary No. 3085 dated 6th December, 2018 as Special Public Prosecutors for the purpose of conducting the trial of



offences under the said Act. This engagement as Special Public Prosecutor shall be co-terminus to the appointment as Additional Government Pleader and Additional Public Prosecutor to the courts specified under section 84 of the Rights of Persons with Disabilities Act, 2016 (Central Act 49 of 2016) and they shall not be entitled to any additional remuneration for discharging the functions of Special Public Prosecutors under the said Act.

Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

Government have designated various Additional District and Sessions Courts as Special Courts in all the districts in the State of Kerala under section 84 of the Rights of Persons with Disabilities Act, 2016 (Central Act 49 of 2016), vide S.R.O. No. 878/2018 and published in the Kerala Gazette Extraordinary No. 3085 dated 6th December, 2018. State Government is empowered to specify a Public Prosecutor or appoint an advocate who has been in practice as an advocate for not less than seven years, as a Special Public Prosecutor under sub-section (1) of section 85 of the Central Act 49 of 2016 for the purpose of conducting cases in the courts specified under section 84 of the said Act.

Government have decided to specify the Additional Government Pleaders and Additional Public Prosecutors who are in charge of the Additional District and Sessions Courts which are notified as Special Courts vide S.R.O. 878/2018 as Special Public Prosecutors for the purpose of conducting the trial of offences under the said Act.

The notification is intended to achieve the above object.
