ORDER

As per the letter read above, the Special Officer, Gender Parks has submitted the drawings and estimates for the first phase of the Gender Park, Kozhikkode for scrutiny and requested to accord administrative sanction for the same to proceed with the estimates and drawing.

- 2) Government have examined the matter in detail and are pleased to accord administrative sanction for setting up of the Gender Park at Kozhikkode for an amount of Rs.12,92,70,272/- (Rupees Twelve crore ninety two lakhs seventy thousand two hundred and seventy two only) after deleting the wrongly provided figures of Rs.11,03,957.53/- each under the heads for electrical and plumbing works and provision for Rs.16,000/- for installation, testing and commissioning of generator set, UPS etc. as these items are not included in the estimate and also subject to the following conditions.
 - 1. The Special Officer, Gender Parks shall submit the detailed estimate, data and drawings to the Government, duly signed by the Head of PMC and recommended by the Director of Social Justice for getting the technical sanction from Government Technical Sanction Committee constituted as per Government Order 2nd read above, before issuing tender notification.
 - 2. The tendering process and acceptance shall be carried out as per the prevailing Government rules.
 - 3. The works shall be executed as per CPWD specification and procedure adopted in PWD manual.
 - Director of Social Justice shall submit proposals to formulate necessary mechanism for test checking of measurements recorded/quality of works through competent Engineers for all Civil/Electrical works of the project.
 - 5. Director of Social Justice shall submit proposal to nominate a competent Government agency for third party inspection before final acceptance of work/setting the final bill.
