4	Asha Bhavan, Thrissur-First floor construction	2,40,00,000/- (Rupees Two Crores Forty Lakhs only)


5	Revovation and extension of old building of Observation Home, Kollam	69,00,000/- (Rupees Sixty Nine Lakhs only)
