### Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport).

Rule 87 of the Juvenile Justice (Care and Protection) Model Rules, 2016 issued by the Central Government and published in the Gazette of India vide G.S.R. 898 dated 21st September, 2016 empower the State Government to constitute a selection committee, by notification in the official Gazette, for exercising the powers and discharging the duties conferred on it by the said Rules.

Government have now decided to re-constitute the selection committee in supersession of the notification issued under G. O. (P) 17/2015/SJD, dated 20th March, 2015 and published as S.R.O. No. 152/2015 in the Kerala Gazette Extraordinary No. 652 dated 23rd March, 2015. The Committee shall have a tenure of three years as stipulated under sub-rule (1) of rule 87 of the said Rules.

The notification is intended to achieve the above object.
