## ORDER

Probation of Offenders Act 1958 is being implemented by Social Justice Department through Probation Officers. Probation system is not only considered as an effective Non Institutional method of preventing the increased rate of offences but also successfully rehabilitating the offenders in the mainstream of society. The Director, Social Justice, as per letter read as 1st paper above, has, therefore, submitted a proposal called 'Nervazhi Project' to rejuvenate and modernize the probation services, staff and the system in Kerala with a total outlay of Rs.2,50,17,700/-. This Project is for a period of two and a half years and is divided into five phases and each phase has a duration of 6 months. The first and the pilot phase of the Nervazhi Project is proposed to be implemented in the current financial year by utilizing an amount of Rs.38,70,700/-. The components of the project and its budget break-up are as detailed below:-
