ORDER

As per the Government Order read as 1st above Government have appointed six members in the Kerala State Commission for Protection of Child Rights, Thiruvananthapuram. Sanction has been accorded for modernization of the office of the Commission in the hired building by entrusting the work to SIDCO for an amount of Rs.7,50,000/- vide Government Order read as 2nd paper above. The Secretary, Kerala State Commission for Protection of Child Rights in his letter read as 3rd paper above has informed that all the six members has assumed charge and the commission is functioning in full swing. Since the Members require exclusive space for hearing and disposal of complaints-and in view of urgency, based on the estimate received from SIDCO, the Work of providing AC cabins, enamel wall coating, fixing curtains in Chairperson's room and the remaining work have been executed at an amount of Rs.6,49,684/-. Therefore the commission has requested to accord Expost facto sanction for the above work.

2. Government have examined the matter in detail and are pleased to accord sanction for the construction of six cabins for the use of members, enamel wall coating work, fixing curtains in Chairperson's room and execution of the remaining work at an amount of Rs.6,49,684/- (Six lakhs

forty nine thousand six hundred and eighty four only) in the office of the Commission. The expenditure in this regard shall be met from the head of account "2235-02-102-53-05-4-other items" in the current year's budget.

The action of the Commission in executing the work in anticipation of the Government Sanction is also ratified.


