ORDER

As per the Government Order read as 1st paper above, administrative sanction was accorded for the on-going schemes of Kerala State Women's Development Corporation (KSWDC) for the financial year 2014-15 for an amount of Rs.6,50,00,000/- and an amount of Rs.325 lakhs was released as per the Government Order read as 2nd paper above. Now, the Managing Director, Kerala State Women's Development Corporation, as per his letter read as 3rd paper above, has requested to release the balance fund of Rs.325 lakhs for the implementation of the Ongoing Schemes of KSWDC for the Financial Year 2014-15.

(2) Government have examined the matter in detail and are pleased to accord sanction for the release of an amount of Rs.1,80,12,000/- (Rupees One crore Eighty lakh and twelve thousand only) under the head of account 2235-02-190-99(P) to Kerala State Women's Development Corporation for the implementation of the Ongoing Schemes for the year 2014-15 subject to the following terms and conditions.

- The amount shall not be parked in Banks/Financial Institutions other than Treasuries. The instructions stipulated in Circular No. 75/2009/Fin dated 29.08.2009 shall be followed.
- The instructions in Circular No. 84/2008/Fin dated 09.12.2008 shall be scrupulously followed.
- The Corporation shall furnish duly authenticated detailed component wise statement of expenditure and Utilisation Certificate in form no. 44 KFC while forwarding the proposal for further releases.
- Fund utilisation shall be strictly in accordance with the scheme wise breakup of Administrative Sanction accorded vide Government order read as 1st paper above. Unspent balance shall be resumed to Government account without fail and the lapse if any will be viewed seriously.
- The amount shall be transfer credited to a non interest bearing TSB account of the Corporation and the amount shall be withdrawn according to actual requirements only. The unutilised amount, if any, at the end of the financial year shall be refunded to Government at the end of the financial year itself.
