## **ORDER**

The Nervazhi project is implemented in the State to rejuvenate and modernize the probation services, staff and the system in Kerala as per the Probation of Offenders Act 1958. The total outlay of the project is Rs.2,50,17,700/-. The project is for a period of two and a half years and is divided into five phases and each phase has a duration of 6 months. As per the Government Order read above, administrative sanction was accorded for implementing the first phase of the Nervazhi Project as a pilot project for an amount of Rs.38,70,700/-. Now, the Director of Social Justice as per his letter read above has informed that the first phase was implemented in four districts namely Kollam, Pathanamthitta, Kannur and Wayanad and will be completed by August 2015. The Director has submitted a proposal for the implementation of the second phase of the Nervazhi project from September 2015 for an amount of Rs.61,44,583/- and that the expenditure in this regard can be met from the head of account 2235-02-001-96 (plan). The details of the project cost of second phase is as follows:

- (3) Government have examined the matter in detail and are pleased to accord administrative sanction for the implementation of second phase of Nervazhi project as detailed above for an amount of Rs.61,44,583/- (Rupees Sixty one lakh fourty-four thousand five hundred and eighty three rupees only) subject to the above condition. The expenditure in this regard shall be met from the head of account 2235-02-001-96 (Plan) in the current financial year.
