ORDER

The Registrar, Subordinate Judiciary as per letter read as 2nd paper above has informed that as per the judgment in the Sessions Court, Manjeri in Case No. 259/2013, the Court have awarded a compensation of Rs. 1 lakh to the rape victim, Kumari Sangeetha aged 3 years, D/o Sivakami, Superintendent in Mahila Mandiram, Thavanoor, Malappuram u/s 33 (8) of Protection of Children from Sexual Offences Act and Rule 7 of the Protection from Sexual Offences Rules.

As per the Judgment read as 1st paper above, the Hon'ble District and Sessions Court, Manjeri have directed that the victim shall be paid a sum of Rs.1,00,000/- towards compensation and the compensation is awarded to be paid by the State Government from the victim compensation fund or other schemes or fund established by it for the purpose of compensating and rehabilitating victims Under Section 357 of CrI.P.C or any other laws for the time being in force or where such fund or scheme does not exist by the State Government.

The Director of Social Justice in his letter read as 3rd paper above has recommended to sanction an amount of Rs.1,00,000/- from the head of account 2235-02-106-93 (P) under the Victim Rehabilitation Component from the current year's budget and deposited in the Bank account in favour of Smt.Sivakami, the mother of the victim.


