(This does not form part of the notification, but is intended to indicate its general purport.)

The Board of Control of Orphanages and other Charitable Homes in the State was reconstituted vide G. O (Ms) No. 25/2020/SJD dated 24<sup>th</sup> September, 2020 and published as S.R.O No. 622/2020 in the Kerala Gazette Extraordinary No. 2196 dated 29<sup>th</sup> September, 2020.
