EXPRESSION OF INTEREST (EOI)

Invited from reputed Institutions working in the field of running Care Homes for Persons with Disabilities to co- operate with Social Justice Department to co function the running of "PunyaBhavan" for the Mentally Challenged children.

DEPARTMENT OF SOCIAL JUSTICE GOVERNMENT OF KERALA

1.0 BACKGROUND

Department of Social Justice (Hereinafter referred as DSJ) ,Government of Kerala is responsible for social protection activities, providing security to the vulnerable and socially dis empowered. In implementation of its mandate, DSJ operating care homes, implements various schemes and welfare programmes for the persons with disabilities.

2.0 PROJECT

Punyabhavan, formerly known as Home for Mentally Deficient Children (HMDC) located at Vellimadukunnu at Kozhikode is the only institution run by the DSJ for the rehabilitation of the mentally challenged children. The Government of Kerala decided to upgrade the institution as model home by providing advanced infrastructural facilities and services to the residents. By providing various services in collaboration with a technical agency selected for the purpose, the institution was upgraded and declared as model home on 11/02/2021. This department desires to continue the project with the technical handhold of suitable organisations/ NGOs having proven track record and expertise in the field. The sanctioned strength of the institution is 50 residents. There are 13 permanent posts are sanctioned in the institution.

Now the following services and programmes are provided to the residents,

Vocational training - It includes activities and training in poultry, art crafts, candle making, gardening, small -scale agriculture and production of decorative items.

Physical training - It includes Yoga/ Meditation, outdoor and indoor games,running and jogging sessions for the physical and mental well being of the residents.

Education service - It includes Daily living skills, Special education and remedial teaching Treatment services - These services includes need - based intervention, behavior therapy, speech and language therapy, occupation therapy etc.

Intervention in General - Appropriate interventions are designed to improve, develop and enhance various skills of the residents.

3.0 SCOPE OF WORK

The period of project is three years. The project aimed for professional care support and respite care service from approved NGOs/ organizations to improve its functioning of the

institution. For these services, approved NGOs/ organizations has to provide Human Resources and implement the services currently implemented in the institution and introduce new services and programmes as appropriate. As part of this, NGO/ organization has to prepare Individual Care Plan of the residents. Individual training should be given to the residents comprehensive assessment and evaluation of each child by a multidisciplinary team of professionals to be done. Programmes to be conducted to give educational support and vocational training to the residents. Under this project, various services including therapy (Speech therapy, Physiotherapy, Music therapy etc), Special education services, medical services, training services, yoga, entertaining and educational activities and any other activity which will improve the mental and physical strength of the residents are included.

The following professional care services are required for the institution:-

- 1.Rehabilitation Psychologist (1)
- 2. Occupational Therapist (1)
- 3.Nurse (2)
- 4. Physical and games Trainer cum yoga Instructor
- 5. House Keeper (3)
- 6. Special Educator (2)
- 7 Physiotherapist (1)
- 8. Speech Therapist (1)

Apart from the above, on call services of the following to be provided on requirement basis-

- 1. General Medical Physician
- 2.Pediatrician/ Neurologist
- 3.Psychiatrist

And other suitable posts can be included in the project. Financial assistance will be provided to the credible institution with clean track records as per the project proposal and guidelines approved by Govt. The proposals thus received will be scrutinized by the technical committee headed by the DSJ. The institution, whose proposals satisfy the eligibility criteria will be invited for a technical presentation on project proposal. The presentation must have to include the methodology of implementation, budget and output. After technical evaluation on different parameters a suitable institution will be selected for implementation of the project.

4.0 ELIGIBILE APPLICANTS FOR EOI

1. Credible Govt organisations/ NGOs approved by the Government of Kerala.

- 2. Should have experience in the disability sector at least for a period of 3 years
- 3. The NGO have sound financial back ground.
- 4. The managing committee / Office bearers of the NGO have good character, antecedents social status and reputation
- 5. The NGOs/Organizations should be having registered office in Kerala and area of work also should be within Kerala geographically.

5.0 CONTENTS OF EOI

• 5.1 NUMBER OF COPIES AND MODE

The information to be submitted by the Applicants in their EOIs is described below in the checklist. The Applicant shall place one (1) original + one (1) copy of the Expression of Interest in a sealed envelope directly to the director of Social Justice.

The technical committee meeting will be held on 26/06/2023 at 11.00 hrs at the Chamber of Director of Social Justice, 5th Floor, VikasBhavan, Thiruvananthapuram 695033.

The agenda of this meeting would include 5 minutes power point presentation by the applicants about the project proposal. The terms of reference will also be decided by a technical and financial committee on the same day. If the number of applications is more than one, then committee will take a decision based on experience of NGOs/Organization in this field, idea in concept paper, cost -output analysis etc
