AAYOG-REGARDING.**

All NGOs receiving grants under different schemes/programmes of the Ministry are required to register with **NGO Partnership- DARPAN** Portal of Niti Aayog immediately and obtain Unique ID. It is also informed that henceforth this Ministry would also not sanction/ release subsequent installments of grant to the existing grantees, in case of ongoing projects, nor consider the new project proposals from NGOs unless they generate UID on this portal and inform to the Ministry.

Dear Ms. Mini,

Integrated Child Development Services, a Centrally Sponsored Scheme, is implemented by the States/UTs. Government of India provides funds to the States/UTs as per approved cost sharing ratio between the Centre and the States/UTs. Training and capacity building is one of the crucial elements of the Scheme, upon which depends the success or otherwise of the programme.

2. For the above purpose, States/UTs are required to submit their State Training Action Plans (STRAPs) for providing training to the field functionaries including Supervisors, AWWs and AWHs. As per the present system, training to these functionaries is either provided by the State/UT run MLTCs/AWTCs or in Partnership with Voluntary Organizations/NGOs or entirely through Voluntary Organizations/NGOs.

3. Sanction and release of funds for providing training to the field functionaries is linked to the STRAP approved by the Ministry. During the current year 2016-17, this Ministry has released the first instalment to the States/UTs on an ad-hoc basis. However, a number of requests from the States/UTs have been received for release of further instalment for running the training courses.

4. In this regard, I would like to draw your attention to NiTI Aayog's letter dated 03.05.2016 (copy enclosed) conveying Government decision that all the Voluntary Organizations (VOs) and Non-Government Organizations (NGOs) have to sign-up the NGO Partnership System (NGO-PS) developed by them and registration on this portal has been made mandatory. VOs/NGOs have to generate a Unique ID, capturing PAN and Aadhar of all the office-bearers/Board of Directors/Promoters to ensure smooth flow of funds. Therefore, VOs/NGOs have to ensure that while applying for any grant, they quote the Unique ID generated from the NGO-PS Portal and furnish the details regarding Unique ID, PAN, Aadhar numbers, E-mail ID and Mobile number of each of its Office bearers/Board of Directors/Members.

the State/UT run MLTCs/AWTCs or in Partnership with Voluntary Organizations/NGOs or entirely through Voluntary Organizations/NGOs as well as the cost of training for each of these three categories for the STRAP proposal which have been submitted for sanction during 2016-17 in order to enable the Ministry examine the same and then release the funds to the States/UTs depending upon the mechanism by which the training is being provided in the State/UTs.

6. It may be noted that the funds in respect of those Training Institutions which are either partially or fully run by Voluntary Organizations/NGOs, compliance to the NITI Aayog's aforementioned letter dated 03.05.2016 is to be ensured including furnishing of information viz. Unique ID generated from the NGO:PS Portal, details regarding Unique ID, PAN, Aadhar numbers, E-mail ID and Mobile number of each of its Office bearers/Board of Directors/Members etc. failing which the Ministry would not be in a position to consider these proposals and release funds to the States/UTs for undertaking training under STRAP.

Deut Shri Somasubramanian,

As you are aware the Central Government and the State Governments allocate a substantial amount of financial grants to Voluntary Organisations (VOs) and Non-Government Organisations (NGOs) every year for various welfare schemes administered by the concerned line Departments/ Ministries. There is, therefore, a need to have a credible database of the NGOs/ VOs, which avail such grants from the government sources.

2. NITI Aayog has developed the NGO Partnership System (NGO PS) Portal with the help of National Informatics Centre (NIC), to facilitate the sign-up of VOs and NGOs. The portal generates a unique ID for the VOs/NGOs on successful sign-up. This Unique ID is being used as a mandatory requirement when the VOs/NGOs approach the Central and State governments for Grants.

3. It has now been decided to make the PAN of VOs/NGOs as mandatory information for registration with the portal. Besides, it has also been decided to capture the PAN and Aadhaar of the Office-bearers/ Board of Directors/ Promoters of the VO/NGOs before these organisations become eligible to apply for Grant(s). The information so captured about these organisations and their functionaries, would be stored in the NGO PS database.

4. Accordingly, I would request you to ensure that, while applying for any grants, the NGOs/VOs:

- (i) Quote the Unique Id generated from the NGO-PS portal;
- (ii) Furnish the details regarding Unique ID, PAN, Aadhar numbers, Email ID and Mobile No. of each its Office bearers/ Board of Directors/ Members.

I would further request you to implement a comprehensive "NGO Proposal Management System" which mandatorily captures the Unique ID generated from the NGO PS portal when these organisations submit proposals for grants every time and make

provision for updating NGO-PS portal at the time of disbursement of funds. Your NGO proposal management system should have, as a minimum, provisions for:

- (i) Submission of application for Grant-in-aid in on-line mode with the concerned line Department/Ministry;
- (ii) Scrutiny of applications (on-line or off-line) and decision-making.
- (iii) Issue of Sanction/Approval Order - online
- (iv) Release of each installment of Grant-in-Aid - online
- (v) Furnishing of Utilisation Certificates (UCs) by the grant-receiving NGO/VO - online.
