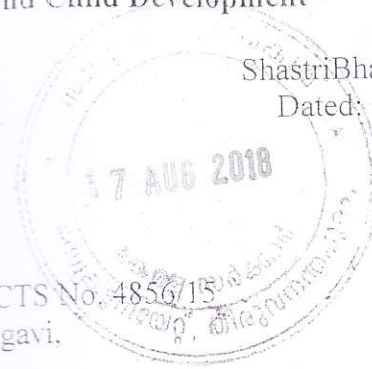

I hereby refer to your RTI application MOWCD/R/2018/80255 dated 01/08/18 transferred to this ministry from M/o Social Justice & Empowerment on 01/08/2018 with reference number: MOSJE/R/2018/80763 in which you have sought information regarding (a) Number of orphans in India state-wise, (b) How much Government is spending for their welfare, (c) What are the Government initiatives or program for them.

2. As per Section 2(57) of the Juvenile Justice (Care and Protection of Children) Act, 2015 "Specialised Adoption Agency" means an institution established by the State Government or by a voluntary or non-governmental organisation and recognized under section 65, for housing orphans, abandoned and surrendered children, placed there by order of the Committee, for the purpose of adoption. As per the norms of Child Protection Services (CPS) scheme, an amount of Rs. 2,35,000 as non-recurring and Rs. 15,50,000/- for a unit of 10 children is provided for Specialized Adoption Agency under the Scheme to the States/UTs.

3. As the complete information sought in the RTI pertains to respective States/UTs, this application is being transferred under Section 6(3) of the RTI Act, 2005 to the concerned departments. Kindly provide the requisite information to the applicant directly.

4. It is also informed that Ms. Aastha Saxena Khatwani, Joint Secretary, Ministry of Women and Child Development, Shastri Bhawan, New Delhi is the First Appellate Authority to CW-II division of this Ministry.
