Dear Sir / Madam,

I am asking these questions under the Right to Information (RTI) Act, 2005. Please provide the following information regarding the children (aged 5-18 years) who are orphan or destitute or who beg, and support offered to them in your state, Uttar Pradesh. If a particular policy, facility or data does not exist in your state, kindly mention "Not available" or "Does not exist" against that item. We are seeking this information in order to assess existing laws and systems on the ground for support, rehabilitation and integration of orphan/destitute/begging children in society, and to explore ways to improve the situation. This questionnaire comprises 5 main sections, numbered 1-5, each with several questions. Kindly provide responses to all the questions. Thank you for your cooperation.

- POLICY/LAW PERTAINING TO SUPPORT AND REHABILITATION OF CHILDREN WHO ARE ORPHAN, DESTITUTE OR BEGGARS:

 - Record of efforts made to contact the child's family/relatives. Record of communication and follow-ups done with them.
 - q. If the child's family/relatives were not contacted or invited then kindly provide record of the reason for doing do.

- r. If the child hails from another state, what effort was made to contact either his/her relatives or the relevant authorities in their state? (Kindly provide record of the same).
- s. If the child was ordered for detention (in Observation Home or Jail) then kindly provide record of the reason for doing so.
- t. Health records with date: All health check-ups done, specialist/doctors consulted, health problems diagnosed, prescriptions made and medication administered; Positive effects or negative side-effects of medications administered.
- u. Health records for special medical problems like HIV/AIDS, TB, Cancer, Dengue, Leprosy,
- v. Records of education, trainings and skill development provided with dates; Tests/examinations taken and certificate of education or skill provided; Record of monitoring and progress of education of skills learned.
- w. If education, training or skill development was not provided, kindly provide record of the reasons for the same.
- x. Records of identity cards made, like Aadhaar card.
- y. Records of economic support provided, if any, for instance to meet cost of health treatment or education or loan for education/skill training or loan for starting an economic activity or for any other purpose.
- z. Records of any appeals or complaints made by the child, and action taken to resolve his/her appeal or complaint. If the child needed legal help in order to present his/her appeal/case, record of providing such help. If such help was not provided or action was not taken or the child was not satisfied, kindly provide record of the reason for the
- aa. If the child died during his/her stay at the facility, kindly provide records (with date) of reason for death, post-mortem conducted, doctor's report, police's report, family or relatives informed and invited, and burial/cremation carried out. If any of these activities were not undertaken then kindly provide record of reasons for the same.
- bb. Present whereabouts of children who have been released; Records of efforts made to contact them to assure that they are fine, healthy and economically stable.


4. FINANCES:

Kindly provide the following data on the children who are orphan, destitute or beggars in your state over the past five (5) years (for every year):

- a. Is a database of such children in the state/districts maintained? Is there a process of identification such a finger prints, ID-cards, etc.
- b. Number of such children at the beginning of the year; out of which how many are living in child homes/shelter/relief/rehabilitation facilities, how many are still on streets, how many live with their families, how many are in jails, and how many in other facilities?



- c. Number of such children fully rehabilitated in society, either on their own or due to government's effort or due to another agency's effort. Break-up of these rehabilitated children based on district, age-group, gender, caste, religion, specific disability categories, etc.
- d. Number of such children who died, and reasons behind their deaths. Break-ups of those who died on the streets, inside jails, in child homes/shelter/relief/rehabilitation facilities, or other places. Kindly provide this data district-wise.
