Kind attention is invited to the reference cited. The information sought in your letter under Right to Information Act is forwarded as follows.

1) Under the Rights Of Persons with Disabilities Act, 2016, the Act comes into force and provides for the disability-friendly use of public spaces within a period of five years. As part of this, the Central Government have formulated the Accessible India Campaign to make the Capital City and public buildings in all the states disabled friendly. On the basis of access audit report on 51 buildings, 28 buildings were found as suitable for retrofitting. The estimates prepared on 28 buildings were included in first phase with a total project cost of Rs. 8.5996 cores were approved by GoI and 1st installment (50%) was released during 2018-Since state PWD is the implementing agency for the construction of Buildings, funds were deposited during 2019-20 with PWD. But PwD requested to release the full amount so as to commence the work of all the 28 buildings. The State Govt have issued Administrative Sanction for retrofitting of all 28 buildings, a priority list of 14 buildings were given to PWD to commence the work immediately. In the said 14 buildings, the building of the Irrigation Department listed as 14 in the priority list has been demolished. Excluding this building, the work of 13 buildings is currently progressing. The proposal has been submitted to the central Govt.for the sanctioning of second installment for the

work of remaining 14 buildings.
